How can you help?

Thank you for joining our 40 Week club. We are excited about this fundraiser which helps our Parish School, Youth and Religious Education programs. Because of your generosity, we are able to help our young people attend CATHOLIC school, attend retreats and enjoy youth ministry events. Part of the funds raised also go to purchase materials and equipment for our kids as well as to maintain areas of the facilities where they gather.

What's this all about?

Investment in our Youth for only \$200 a year.

Each week, there are two drawings for those who are up to date on their payments for cash prizes of \$30/\$60. Quarterly, one person will win \$100 in the drawing. (Most people returned the \$15 so we've just used that to increase the top two weekly prizes.)

Every weekly drawing includes all up-to-date members.

At the end of the year, in connection with the Feast of St. Teresa, we schedule a social get-together where top cash prizes are drawn. Everyone paid up to date is eligible for the \$1,000.00 top prize.

Become a seller by inviting people to join the club. Every time one of your invitees wins, 10% of their winnings goes to you. Sellers receive one check for all their efforts at the end of the club.
